Laura F. Sudler, LLC thru Mesa Creek, Inc and Guest agree as follows:

1. OCCUPANCY: Guest is an adult (meaning person over 18 years of age) and will be an occupant of the unit during the entire reserved period. Other occupants will be family members, friends or responsible adults. Use of the premises will be denied to persons not falling within the foregoing categories, and as a result they would have to vacate the property immediately without any refund. **THERE SHALL BE NO MORE THAN 6 PEOPLE STAYING AT THE PROPERTY DURING THE TIME PERIOD RESERVED BY GUEST.**
2. SECURITY DEPOSIT - Rental insurance thur VRBO.com and/or credit card number authorized on file incase of damage: Guest is also required to complete the following: **Visa or Master Card** information (please circle one):

**\*\*Guest’s signature on this document confirms authorization for Mesa Creek, Inc. to debit Guest’s credit card account for the security deposit and then total rental price and/or to reimburse Laura F. Sudler, LLC thru Mesa Creek, Inc. for costs in excess of the security deposit incurred to repair/replace damaged or missing items at the time of Guest’s departure. By signing this document Guest accepts liability for any missing items, damages caused to the property (including unpaid rental fees or excessive cleaning fees) (other than normal wear and tear) by Guest and/or Guest’s family and invitees including, but not limited to damage to landscaping, misuse of appliances, and/or equipment provided by Laura F. Sudler, LLC thru Mesa Creek, Inc.. \*\* Please make sure Guest has provided the same billing address above as on file with the credit card company.**

3. **PAYMENT:** Guest agrees to pay Laura F.Sudler, LLC thru Mesa Creek, Inc. a **rental fee of \_\_\_\_\_ and \$80** Cleaning fee to be paid in full 6 weeks prior to the reservation dates. If Guest pays by personal check rather than credit card and the check is returned for insufficient funds there will be a \$50 service charge. Checks should be made payable to Laura F. Sudler, LLC.
4. **CANCELLATIONS/DEPOSIT REFUNDS:** Due to the nature of the vacation rental business, Laura F. Sudler, LLC thru Mesa Creek, Inc. cannot accept cancellations. Guest will forfeit all sums paid unless Laura F. Sudler, LLC/Mesa Creek, Inc. is able to re-rent the property to someone else, at the same rate, for the same period. If Mesa Creek, Inc. is successful in finding another lessee then any payment received by Guest will be refunded less 20% of the weekly rate.
5. **CHECK IN:** Check in time is 3:00 PM. OK for EARLY CHECK IN. Keys for the Property will be issued to Guest by management in person or via lock box at check-in time. No keys will be issued to anyone who is not an adult. The lockbox combination or keys WILL NOT be issued with a balance owed or without a signed rental agreement and credit card receipt in Mesa Creek, Inc.'s possession.
6. **CHECK OUT:** Check out time is 10:00 AM, PRIOR APPROVAL IS NEEDED FOR LATE CHECK OUT. Please leave all keys and any remote controls at the property. A replacement fee will be charged for each lost key or remote control.
7. **CLEANING/INSPECTION:** The Property will be inspected, household items counted and checked, and the Property cleaned after guest departure. The cleaning fee paid by Guest (\$80) will provide for three hours of normal cleaning so that Guests may enjoy their vacation up to the last moment. GUEST IS REQUIRED to leave the Property in the same general condition in which it was received and to assume responsibility for any loss or damage beyond normal wear and tear. Guest should place dishes in the dishwasher and check that the home is generally picked up and ready to be vacuumed and dusted. The \$80 cleaning fee will be charged up front. Laura Sudler thru Mesa Creek, Inc. reserves the right to compensation for any damage or excessive cleaning charges caused by Guest or any member of Guest's group.
8. **WHAT WE PROVIDE:** The Property is equipped and set up as a fully furnished property that will include bedding, pillows, towels, as well as a fully equipped kitchen, furnishings, and outdoor furniture. Although we made every effort to anticipate most people's needs, WE MAY NOT HAVE ALL THE ITEMS YOU MAY BE ACCUSTOMED TO HAVING AT YOUR OWN HOME.
9. **WHAT GUESTS SHOULD BRING:** Although the bathroom will be stocked, guests may prefer to bring personal items such as bath soap, shampoo, hair dryer, other personal toiletries and laundry detergent. Guests must provide their own food and condiments.
10. **TELEPHONE:** Please use your cell phone
11. **SMOKING WITHIN THE HOME IS NOT PERMITTED.** Smoking at the Property will result in an additional charge (\$200) to the credit card on file or will be deducted from the security deposit. **PETS ARE NOT ALLOWED ON THE PROPERTY.**
12. Guest **PARKING** is allowed only on the gravel driveway. Mesa Creek, Inc. reserves the right to tow any car parked elsewhere, including on the side lot.
13. **SKI** equipment and other outdoor sports equipment must be stored in the provided side covered porch or in Guest's car. Laura Sudler or Mesa Creek, Inc. is not in any way responsible for this equipment, including but not limited to if it is lost, stolen or damaged.
14. **PATIOS:** Guest hereby acknowledges that at the Property they have reserved, the patio/deck can be slippery when wet or icy and that injury is likely to occur to anyone who is not careful. Guests should observe and adhere to all rules and policies as posted at the property. With full knowledge of the above facts and warnings, the undersigned accepts and assumes all risks involved in or related to the use of patio areas.

15. SLEEPING CAPACITY/DISTURBANCES: Guests and occupants will be required to vacate the premises and forfeit the rental fee and be charged a \$250 fee for any of the following: A. Occupancy exceeding the sleeping capacity (6) stated on the reservation confirmation. B. Using the Property for any illegal activity including, but not limited to, the possession, serving or consumption of alcoholic beverages by or to persons less than 21 years of age. C. Causing damage to the Property or to any of the neighboring properties. D. Any other acts which interfere with neighbors' right to quiet enjoyment of their property. IF, FOR ANY REASON, LAW ENFORCEMENT IS NOTIFIED DUE TO DISTURBANCES EMANATING FROM THE PREMISES OR GROUNDS, THERE WILL BE A MINIMUM \$250 CHARGE TO YOUR CREDIT CARD PER INCIDENT.
16. In the event that Guest breaches any of the terms/conditions of this Agreement, Laura Sudler and Mesa Creek, Inc. shall be entitled to attorney's fees and or damage deposits in any action brought to enforce the terms hereof.
17. HOLD HARMLESS: Laura F. Sudler, LLC and Mesa Creek, Inc. assume no liability for loss, damage, or injury to persons or their personal property staying at the Property. Neither does Laura F. Sudler, LLC or Mesa Creek, Inc. accept liability for any inconvenience arising from any temporary defects or stoppage in supply, water, gas, electricity, or plumbing services. Nor will Mesa Creek, Inc. accept liability for any loss or damage caused by weather conditions, lack of snow, natural disasters, acts of God, or any other reasons beyond its control. Refunds will not be issued for any of the aforementioned items.
18. Guest shall not assign this Agreement or sublet the premises.
19. No processing of animals on the property or in the house from a hunt. If this happens it will result in an additional charge (\$300) to the credit card plus additional cleaning costs.
